

NOTIFICATION OF A PUBLIC PARTICIPATION PROCESS

PROPOSED INFILLING OF WETLANDS IN PHASE 5 AND 6 AND AMENDMENT OF THE EXISTING ENVIRONMENTAL AUTHORISATION FOR THE BARDALE VILLAGE DEVELOPMENT ON ERF 27033 AND 7584, KUILS RIVER

Proposal and Location: This application is for the development of infrastructure in close proximity to wetlands as well as the infilling of wetlands in Phase 5 and 6 and amendment to the existing environmental authorisation (EA) for Bardale Village on Erven RE/20733 and 7584, Kuils River. In terms of the EIA Regulations, 2014 (as amended) a Basic Assessment process must be followed as part of the application for Environmental Assessment. The intention of this application is to change a portion of the land use of Phase 5 to accommodate retail use and for Phase 6 to only accommodate residential use. Further to this it is to update the holder of the EA's details as the company name changed from Integrated Housing Development (Pty) Ltd to Bardale Village Development (Pty) Ltd.

The site is located in Bardale in Blue Downs. The development can broadly be described as being located on a portion of the land between: R300 (west), Stellenbosch Arterial (M12) (north), Van Riebeeck Road (R102) (east) and Hindle Road (M54) (south).
